Kittson Healthcare 2019 Community Health Needs Assessment Implementation Plan

Kittson Healthcare has reviewed our 2016 Community Needs Assessment and Implementation Plan. We also conducted a targeted Community Health Needs Assessment to key members of the community and to the senior citizen centers of the county to determine what the residents of our service area felt were opportunities for improving health and healthy living in Kittson Healthcare's primary service area. We organized a meeting of individuals representing services and agencies from our county to review the assessments and data that we had collected.

As a result of this assessment, there was a consensus of concern for the continuation of emergency room, dental, retail pharmacy, and optometry services within our service area. Secondly, we reviewed surveys conducted of unmet senior citizen needs that if addressed would allow for extended "aging in place". Third, as a facility, we want to continue to provide our residents, both adults and youth, with more information and support to promote healthier eating habits; knowledge of the effects of overuse of alcohol; the health consequences of tobacco usage, including vaping; the warning signs of cancer and heart disease; and the further promotion of the importance of vehicle seat belt usage. These were all areas of concern from our data assessment of 2019.

In reviewing our Implementation Plan of 2016, we have made progress in nearly all areas of our 2016 Implementation Plan. Kittson Healthcare established their own retail pharmacy in August, 2019 therefore, meeting the community's concerns about ongoing pharmacy services following the retirement of our one pharmacy in the community of Hallock.

Though a variety of other needs were identified, the community recognized that it had limited resources and capacity and wanted to set realistic and achievable goals. The following provides an outline of what Kittson Healthcare will do to address the results of this Community Health Needs Assessment:
