PUBLIC INFORMATION FOR COMMUNITY CARE

Kittson Healthcare may make available and provide, upon request, community health care in a reasonable amount to persons who are unable to pay for these services including those medically indigent. These community care services may be offered as follows:

1. Services will be provided for patients at Kittson Healthcare.
2. Low income patients with self-pay balances may apply for community care assistance.
3. Services eligible for community care are limited to those provided at Kittson Healthcare.
4. A written determination of approval or denial will be provided to the applicant after screening is completed.
5. If an application for community care is reviewed and approved, the patient should find appropriate healthcare coverage for future visits (Minnesota Medical Assistance, Minnesota Care, private insurance company). Community care is not an ongoing solution and should not be treated as such.

Although each application will be dealt with on an individual basis, the following Federal guidelines as to annual income will signify a starting point in the eligibility process:

100 % Poverty Guidelines = Charges reduced to zero
 135% x Poverty Guidelines = 75% reduction in charges
 185% x Poverty Guidelines = 50% reduction in charges
 200% x Poverty Guidelines = 25% reduction in charges
